Q. When does the Competition start and end?

The Competition starts at 12.01am (AEST) on 01/05/2018 and ends at 11.59pm (AEST) on 31/07/2018.

Q. Who can enter the Competition?

The Competition is open to:

- Australian businesses that purchase Reflex paper (not for re-sale) either directly from the Promoter or from one of the Promoter's distributors (*Commercial Customers*); and
- Australian individuals and consumers (*Retail Customers*).

If you are entering on behalf of a Commercial Customer, you must be a principal or staff member of the Commercial Customer who is aged 18 or over and is authorised to represent the Commercial Customer in all aspects of the Competition.

If you are entering as a Retail Customer and you are under 18, you must obtain approval from your parent/guardian before you enter.

You must also be an Australian resident.

Q. Do I have to buy anything to be eligible to enter?

Yes, you must purchase a minimum of two (2) A4 Reflex reams (including Ultra White, Recycled, Colours) or one (1) carton of Reflex unwrapped (equivalent to five (5) reams) in **one transaction** (*Qualifying Purchase*).

Q. What products can I purchase to enter?

Ultra White

- Reflex Ultra White Carbon Neutral A4
- Reflex Ultra White Carbon Neutral Unwrapped A4 (one (1) carton is equivalent to five (5) reams)
- Reflex Ultra White 550 Sheets A4
- Reflex Ultra White 4 Hole Punched A4
- Reflex Ultra White 3 Hole Punched A4
- Reflex Ultra White 2 Hole Punched A4

Recycled

- Reflex 50% Recycled Bright White Carbon Neutral A4
- Reflex 100% Recycled White A4
- Reflex 100% Recycled Carbon Neutral White A4

Colours

- Reflex Colours Blue A4 80gsm
- Reflex Colours Gold A4 80gsm
- Reflex Colours Green A4 80gsm
- Reflex Colours Mauve A4 80gsm
- Reflex Colours Pink A4 80gsm
- Reflex Colours Sand A4 80gsm
- Reflex Colours Yellow A4 80gsm

Q. How do I enter?

After you have made a Qualifying Purchase (which is when you purchase a minimum of two (2) A4 Reflex reams in **one transaction**), you must, during the competition period, visit www.reflexwinamillion.com.au and fill out and submit the online entry form. This will include uploading an image of the Qualifying Purchase receipt (or equivalent proof of payment, if you are entering on behalf of a Commercial Customer).

Q. How many entries will I receive into the Major Prize Draw for each Qualifying Purchase?

- Each A4 Reflex ream purchased in the one transaction equals one (1) entry into the Major Prize Draw. A minimum of two (2) reams of Reflex A4 must be purchased in the one transaction to be eligible to enter.
- Each carton of Reflex A4 Unwrapped purchased in the one transaction is equal to five (5) entries into the Major Prize Draw. Only one (1) carton of Reflex Unwrapped must be purchased in the one transaction to be eligible to enter.

Examples:

- If you buy one (1) ream of Reflex A4 Ultra White in one transaction, you are **ineligible** to enter.
- If you buy two (2) reams of Reflex Ultra White in one transaction, you will be eligible to enter the Major Prize Draw two (2) times and the Instant Win Prize Draw once (1).
- If you buy five (5) cartons of Reflex unwrapped in one transaction, you will be eligible to enter the Major Prize Draw twenty-five (25) times and the Instant Win Prize Draw once (1).

Q. How many times can I enter the Major Prize Draw?

You can receive up to a maximum of 100 entries into the Major Prize Draw.

Q. How many entries will my Qualifying Purchase give me into the Instant Win Prize Draw?

Each Qualifying Purchase equals one entry into the Instant Win Prize Draw.

Q. How are the Instant Win Prizes Drawn?

There are 50 Instant Win Prizes to be drawn based on predetermined times during the competition period selected by a computerised random system. Once you have entered the competition on the website, you will instantly receive a message onscreen informing you if you have or have not provisionally won an Instant Win Prize. If you do win an Instant Win Prize, your Qualifying Purchase will subsequently be verified before delivery of your Instant Win Prize.

If a Commercial Customer is determined as a prize winner, the principal of the relevant winning Commercial Customer will be deemed the recipient of the relevant prize on behalf of the Commercial Customer, irrespective of who submitted the entry.

Q. What are the Instant Win Prizes?

Each instant win prize is a \$100 Visa Gift Card.

Q. Is there a limit on the number of Instant Win Prizes I can win?

Yes, (except for South Australian residents), Instant Win Prizes are limited to one (1) Instant Win Prize; per person for Retail Customers; or per Commercial Customer irrespective of how many principals/authorised representatives enter the competition on behalf of the Commercial Customer.

Q. What happens if I win the Major Prize Draw?

If you are the Major Prize Winner (or the Major Prize Winner's representative) you will be given the chance to choose one (1) envelope from a set of one hundred (100) envelopes. One (1) of the envelopes will contain a note saying "You have won \$1,000,000" and the remaining ninety-nine (99) envelopes will contain a note saying "You have won a consolation prize of \$10,000". If you select the envelope that says you have won \$1,000,000, you will receive a prize of \$1,000,000. If you select an envelope that says you have won \$10,000, you will receive a prize of \$10,000.

Q. Do I need to keep my receipt?

Yes, you must retain your original receipt (or for Commercial Customers, the equivalent of an original receipt, such as a remittance advice) as proof of your qualifying purchase which must clearly identify: the store where you made the Qualifying Purchase; and the date of the Qualifying Purchase or, in respect of Commercial Customers, the date on which payment of the Qualifying Purchase was made (which must be during the competition period).
